Village of Jacksonville Electric Company NOTICE OF PROPOSED RATE CHANGES

On September 27, 2024, the Village of Jacksonville Electric Company filed revised tariffs with the Vermont Public Utility Commission (PUC) requesting an increase in its retail rates of 25.000%. The overall increase in costs for the Electric Company is due largely to increases in the operation and maintenance, power supply, and labor cost categories. The proposed retail rate schedule is to be effective on a service rendered basis beginning November 11, 2024.

To determine the impact on your individual bill, use the proposed rates column and your average monthly consumption. For example, a residential customer using 600 kWh a month would calculate their bill as follows:

The Public Utility Commission has no authority to suspend this rate request. If the PUC decides not to open a formal investigation, the rates will take effect November 11, 2024, on a permanent basis. However, the PUC may order a formal investigation and hearing on the proposed rate changes. Until completion of that formal review by the PUC, the increase would be listed as a surcharge on your bill. Any person wishing to comment on the proposed rate change should file their views in writing via the PUC's electronic filing system which can be found at https://epuc.vermont.gov/ and use **Case No. 24-3018-TF**. Comments may also be submitted by regular mail at Vermont Public Utility Commission, 112 State Street, Montpelier, Vermont 05620-2701.
